Personal/Individual Service: \$45.00

Includes speaking to neighbors in case the address is not good (New Jersey Only)

Business/Corporate Service: \$35.00

Corporation, Custodian of Records, Manager, Director, Person in Charge (New Jersey Only) -- NJ Registered Agent Search only \$19.95

Corp.Trust Co./Corp. Service Co.: \$25.00

Registered Agent Companies Trenton, NJ address only

Out of State Service: \$95.00

Non-Service Affidavit \$65.00

Foreclosure Service Fees

Husband and Wife Discount: Fee + 2.50

Must be served at the same address

Posting of Service: \$25.00

Property Inspection: \$70.00

Must be done at the same time of service/includes 2 pictures

Municipal Lien Research: \$30.00

Property Taxes, Municipal Lien, Assessed Owner, Assessed Values, Water and Sewer

Other Fees

Filing of Affidavits: \$ 5.00

To keep cost low this is hand delivered to court weekly or mailed

Multi-Service Discount: Fee + \$ 5.00

In order to receive discount, process must be received at the same time, must be served on the same entity at the same address

Same Day Service: Fee + \$30.00

Documents must be received by 12:00 noon for any Business or Corporation Service and received by 4:00 pm for home addresses

Next Day Service: Fee + \$20.00

Must be received by 4:00 pm

Locates: \$40.00

Performed as long as it is docketed with the courts
